## MyDailyMoment 2023 Sweepstakes

## **OFFICIAL RULES**

Important: Please read these Official Rules before entering this Sweepstakes (the "Sweepstakes"). By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

Sweepstakes void where prohibited by law. Subject to applicable federal, state, and local laws.

- 1. Eligibility: The Sweepstakes is open only to individuals who are legal residents of the 50 United States or the District of Columbia and are at least 18 years old (or the age of majority in their state of residence, whichever is older) at the time of entry. Sponsor's or its designee's computer is the official time-keeping device for the Sweepstakes.
- **3. How to Enter:** To enter, complete the following steps during the Sweepstakes Period:
- (1) Go to <u>www.mdmexclusives.com</u> and provide the requested information (e.g., your name and email address) in the Sweepstakes entry form; and (2) follow the instructions to view the sales offers on the website until you reach the final confirmation page. No purchase or payment of any kind is necessary to enter.

<u>Limit</u>: ONE ENTRY PER PERSON PER DAY DURING THE SWEEPSTAKES PERIOD. Any attempt to obtain additional entries, including through multiple or duplicate accounts will result in disqualification.

**4. Identity of Entrant:** All entries must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email or social media account. Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification, at Sponsor's sole discretion.

In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address associated with the account used provided for entry. An "authorized account holder" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide Sponsor with proof that a potential winner is the authorized account holder of the account associated with the winning entry.

**5. Selection and Notification of Winner:** On or about **January 15, 2024** Sponsor will select the name of one prize winner in a random drawing from among all eligible participants at Sponsor's headquarters as listed in Section 15 below. The odds of winning depend on the number of eligible entries received.

The potential winner will be notified via email and/or phone on or about January 31, 2024.
